Subject: New Kansas Roofing Legislation

Many of you are likely aware of the new legislation in Kansas that requires anyone doing roofing work in Kansas to register and pay an annual fee to do so within the State of Kansas. There is information at the attorney general's web site regarding this legislation.

Following is an excerpt from Attorney General's web page talking about the legislation and then, secondly, the CDBG staff instructions as to how to comply immediately.

The Kansas Roofing Registration Act was enacted by the Kansas Legislature and signed by the Governor on April 22, 2013. Under the provision of this law, on or after July 1, 2013, every "roofing contractor" must obtain a roofing contractor registration certificate from the Kansas Attorney General in order to legally provide commercial or residential roofing services for a fee in Kansas.

Due to this law, any contractor or subcontractor providing any type of roofing work in a CDBG project must be registered. Effective immediately if any roofing improvement appears in the scope of work, proof of registration must be on file before a contract is awarded or work performed. In other words, if a contract has been awarded but the roofing line item is not yet complete proof of registration is required before work begins. If a subcontractor will be performing the work, the subcontractor and the general contractor must be registered. The ONLY exception to this requirement is if the cost of roofing in the contract is below \$2,000. The contractors/subcontractors can find more information about this register at the below site. You, the administrators, may require proof of registration or you can check the registration listing at this same site. https://ag.ks.gov/in-your-cornerkansas/resources/roofing-registration

- 2. Provide the following documents with the completed application:
 - a. Certificate of liability insurance, which shall be not less than \$500,000, and which shall list "Office of the Kansas Attorney General, 120 SW 10th Ave., Topeka, Kansas 66612" as the certificate holder;;
 - b. Certificate of workers' compensation coverage or affidavit of exemption or self-insurance; and
 - c. Certificate of current tax clearance or letter from the Kansas Department of Revenue. Available at www.ksrevenue.org/taxclearance.html
