DEMOLITION PILOT PROGRAM

Administered by North Central Regional Planning Commission through a partnership with the Dane G. Hansen Foundation

About the Program

Property owners in eligible counties may apply for a grant reimbursement to demolish a dilapidated residential structure (e.g. house, etc.) by completing the attached application and submitting the documentation listed below.

Who is Eligible

2024 eligible service locations include the following Kansas counties:

Logan, Osborne, Ottawa, Phillips, Rawlins and Sherman Counties

- Assistance is available on a first come, first served basis. *Funding is limited on a per county basis.*

How it Works

- A maximum grant of \$5,000 per property is available. Please note that owners must provide proof of payment for the removal and cleanup of dilapidated properties for which they will be reimbursed for the exact cost up to, but not exceeding, \$5,000. Contact Keegan Bailey at NCRPC to discuss other payment arrangements if needed.
- Demolition project **must be complete within 90 days** after the application is approved by the NCRPC.
- Only one application per property owner.
- This is not an income-based program; anyone may qualify. However, if adjusted gross income for the household is greater than the maximums listed in the table below, a IRS 1099 Miscellaneous Income Form will be issued. If not enough income to file taxes, a signed and notarized statement of such will be required.

Demolition Pilot Program

How to Apply

To apply, submit the items listed in the checklist below. Email is preferred for everything except the Letter of Intent Certification (signed and notarized), which must be mailed. Requested documents may be sent to:

Please note that submitting ALL items in the checklist below is required to process your application.

- Completed application (Page 3)
- Verification of property ownership – *Copy*
Deed must be registered at the Register of Deeds Office in property owner(s) name.
- Verification of most recent paid real estate taxes – *Copy*
Need receipt of 1st half or full payment of property taxes paid in December and/or May. This can be obtained from the County Treasurer's Office.
- Copy of Form 1040, U.S. Individual Income Tax Return(s), for the 2023* tax year (excluding schedules).
**If taxes are in extension, then ineligible. Adjusted gross income is used to determine if a 1099 will be issued.*
- A "before" color photo of project. A final "after" color photo of the project will be required for reimbursement.

Further documentation (i.e. proof of payment to the contractor or financial institution) for the project completion will be obtained at a later date for reimbursement.

Also needed:

Within 10 days of submitting an application and the supporting documentation listed in the checklist above, the original Letter of Intent Certification will need to be received by NCRPC to retain your reserved slot.
