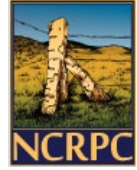

Housing Programs Available Soon in Six Kansas Counties

Dane G. Hansen Foundation/NCRPC Housing Initiative partnership includes financial assistance for moderate-income housing rehabilitation, demolition pilot programs

BELOIT, KS, August 1, 2025 — Financial assistance for moderate-income housing rehabilitation or demolition of dilapidated residential structures will be available for a limited time in six Kansas counties beginning August 19th. The programs are administered by the North Central Regional Planning Commission of Beloit, Kansas, through a partnership with the Dane G. Hansen Foundation of Logan, Kansas.

The following six counties are eligible for assistance: Ellsworth, Saline (located outside Salina city limits), Sheridan, Thomas, Trego and Wallace Counties. Assistance will be available to eligible residential property owners on a first-come, first-served basis, with funding limited per county.

The Demolition Pilot Program offers reimbursement grants of up to \$5,000 per property for the removal and cleanup of dilapidated residential structures. There are no income requirements for the demolition program.

The Moderate Income Housing Rehabilitation Pilot Program offers reimbursement grants of up to \$10,000 to homeowners in eligible counties to complete minor housing upgrades. Examples of eligible housing upgrades include items such as roofing, siding, windows, or heating and air units. Homeowners must provide a 10 percent match up to \$1,000 and pay any costs above and beyond the \$10,000 grant. Please note that rental properties are not eligible for

this program, and households must meet moderate income guidelines outlined in the program application to qualify.

“We are grateful for the continued support of the Dane G. Hansen Foundation in helping to make these programs possible through the NCRPC Housing Initiative,” said Keegan Bailey, NCRPC Housing Director. “Housing is critical for communities, and these programs will help preserve housing stock, address housing rehabilitation needs that often go underserved by other programs, and eliminate dilapidated structures that can impact the health and safety of neighboring residents.”

The first pilot programs for the NCRPC Housing Initiative launched in 2022 in Cloud, Jewell, Lincoln, Mitchell, Russell, and Smith Counties. In 2023, the programs expanded to Cheyenne, Decatur, Gove, Graham, Republic, and Rooks Counties. In 2024, assistance became available in Logan, Osborne, Ottawa, Phillips, Rawlins, and Sherman Counties. Applications for the 2024 Demolition Pilot Program are still being accepted for Logan County, Ottawa County, Phillips County, Rawlins County, and Sherman County for a limited time.

Applications for the 2025 program will be available **online only** beginning August 19th after 9 a.m. Central Time. Anticipated demand may result in delayed response times for inquiries immediately following the program launch.
